However, as the only member of the UK's most recent Marine Energy Programme Board invited to represent the cause of the tidal range agenda, I do believe that as a speaker I might have something useful and original to offer - namely an environmentally, economically and socially relevant and innovative 'diagnosis and treatment' for making high-flow, two-way tidal range technology more fully and sustainably fit-for-purpose worldwide...

I've therefore copied in the person who kindly arranged for me to join this Board - namely Prof. David Mackay (DECC's former Chief Scientific Officer) – to consider sending you a recommendation.

For reasons that should become clear on reading the attached, if I was given this opportunity I would endeavour also to invite Rolls-Royce representation - this company being the owner of the relevant IPR.

For this reason it seems highly important that Rolls-Royce is also strenuously encouraged to participate, and I would endeavour to ask others to help me do my best to encourage this via relevant company and political contacts.
